1st -2nd -3rd place medals in each weight division. Modified double elimination system will be used, three or fewer contestants will use a round robin system. If there is only one contestant in a division the contestant may compete in the next heaver division otherwise a competitor may only compete in one division. For the overall High School award 1st thru 5th place points in the varsity division will be counted. (10-7-5-3-1)

ELIGIBILITY

High School Event: All competitors must be: at least 15 years of age and no more than 19 years of age: in at least 9th grade enrolled full-time, and in good standing in a high school in Oregon, Washington, Idaho, or British Columbia. May be of any rank. (Upon request of coach and parent/guardian tournament Director may waive age requirement) **Middle School event** All competitors must be: at least 12 years of age and no more than 15 years of age: in at least 7th grade enrolled full-time, and in good standing in a Middle school or Junior High School in Oregon, Washington, Idaho, or British Columbia. May be of any rank. **Students in 9th grade may elect to compete in the High School Event and/or the Middle School Event. Students wishing to do so must submit two entry forms (no second waiver is required). Middle School (9th grade) entrants will be fighting under Senior High School rules if they choose to compete in Senior High School divisions.**

2. I further acknowledge that prior to participating, I will inspect the mats, equipment, facilities, competition pools or divisions, and the elimination or scoring system to be used, and if I believe anything is unsafe or beyond my capability, I will immediately advise my coach, supervisor, and/or tournament official of such conditions and refuse to participate.

3. I acknowledge and fully understand that I will be engaging in a contact sport that might result in serious injury, **Traumatic Brain Injury (TBI)**, illness or disease, including permanent disability or death, and severe social and economic losses due not only to my own actions, inactions or negligence, but also the actions, inactions, or negligence of others, the rules of the sport of Judo, or conditions of the premises or of any equipment used. Further, I acknowledge that there may be other risks not known to me or not reasonably foreseeable at this time.

4. Knowing the risks involved in the sport of Judo, I assume all such risks and accept personal responsibility for the damages following such injury, illness, disease, permanent disability, or death.

5.
