Competition will be held for the following kata: Nage-no-Kata, 2. Ju-no-Kata, 3. Katame-no-kata, 4. Kime –no-Kata\*, 5. Kodokan Goshinjutsu\*- \*Senior advanced only

**Divisions:** Male, Female, and Co-ed teams will compete together within each category

Junior Novice: under 17 years old, first year of kata competition

Junior Advanced: Under 17 years old

Senor Novice: Over 17 years old, ranked below shodan, or first kata competition

Senior Advanced: Over 17 years old, ranked shodan or above.

Competitors may enter as novice for kata which they meet the requirements, while entering as advanced for other kata in which they have more experience.
